# Identifying information




- ◆ **Legal Status:** Association.

Networking is essential for the collective, which has an extensive network of collaborators with broad experience in the defense of migrants' rights.


# Thematic areas

## #RightToLife

365 days a year, we monitor the risk situations faced by people at migratory crossings at the Euro-African Western Border. We provide a coordinated response with the countries' rescue services, documenting violations of the right to life, and build a narrative of memory, truth, reparation, justice and non-repetition.

## #PainIntoJustice

We support and accompany people on the move and their families in restitution and reparation processes in the face of rights violations during migration processes (disappearances and deaths at sea, family separations, illegal returns and other forms of torture), carrying out transnational and cross-cultural mediation work with the communities.





These areas of work are interrelated and serve to nurture the Human Rights Observatory where, through communication and applied social research, we work for the defense of the rights of people on the move.

# Geographical area

For more than 20 years we have been working for the defense of people and communities on the move in the Euro-African Western Border, that is the set of land and maritime spaces located between the Spanish State, on the one hand, and the African coastal strip, from the south of Senegal to the province of Jijel, in Algeria.

In the coming years we hope to continue working on this border and denouncing and making visible the violations committed in the following migratory routes:

- Canary route.
- Strait of Gibraltar route.
- Alboran Sea Route.
- Algerian route.
- Land borders in Ceuta and Melilla.








# Income and expenses 2024
